101 APPEAL DECISION

An Appeal Decision was received ALLOWING: Removal of buildings and other structures and construction of up to 750 dwellings, primary school, care village, local neighbourhood facilities to include retail development (use classes A1, A2, A3, A4, A5), community building (use class D1), parking, comprehensive green infrastructure comprising formal and informal open space, footpaths, cycle ways, water areas (also including sustainable drainage systems) and landscaping, new access points to Watery Lane and Netherstowe Lane and improvement to Netherstowe Lane (all matters reserved except points of access) at land north east of Watery Lane, Curborough The City Council's comment on 13 February 2014 was "Recommend Refusal; the site has been considered and rejected in the emerging Local Plan for a variety of sound reasons. It would form an incongruous development spur into open countryside on a greenfield site, and the access via Watery Lane (with its narrow skew railway bridge) and the very narrow Netherstowe Lane, are totally inadequate to meet the requirements of such a large development."

RESOLVED: That a letter be sent to the Secretary of State expressing the concerns of the City Council regarding the decision.

RESOLVED: That the Ward Councillors consider the proposals in their area and forward their comments back to the Town Clerk for submission.

104 STREET NAMING

Further to Minute No 92 [Planning Meeting dated 2 February 2017] concerning naming streets on the former Hepworth Site. Lichfield District Council have stated that it has been suggested that the 7th road be named after 'Watchman' after the Staffordshire Regiment mascot.
