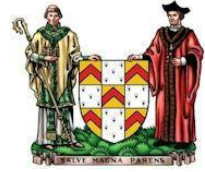

Privacy Notice

When you hire the Market Square, Pool Walk, any pitch or pitches thereon, or any other facility under the direct control of the City Council, the information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you, respond to your correspondence, provide information, and send invoices and receipts relating to your hire agreement. Your personal information will not be shared with any third party without your prior consent.

When you contact us

The information you provide will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will not be shared or provided to any other third party.

The Councils Right to Process Information

Processing is with consent of the data subject.

Processing is necessary for compliance with a legal obligation.

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.

Information Security

Lichfield City Council has a duty to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies. Copies of these policies can be requested.

We will only keep your data for the purpose it was collected for and only for as long as is necessary. You may request the deletion of your data held by Lichfield City Council at any time.

Access to Information

You have the right to request access to the personal data we hold relating to you. You can do this by contacting our Data Information Officer, the Town Clerk, Donegal House, Bore St, Lichfield WS13 6LU.

Information Correction

If you believe that the information we have about you is incorrect, you may contact us so that we can update it and keep your data accurate. Please contact the Markets Officer at the address above.

Information Deletion

If you wish Lichfield City Council to delete information about you, please contact the Town Clerk at the address above.

Right to Object

If you believe that your data is not being processed for the purpose it has been collected you may object; please contact the Town Clerk at the address above.

Rights Related to Automated Decision Making and Profiling

Lichfield City Council does not use any form of automated decision making or the profiling of individual personal data.

Complaints
