#### 5. TRADER REPRESENTATIONS

The following questions have been submitted by Traders; the Markets officer will provide an update at the meeting.

1. Some traders worried that some Facebook posts for other events will pull people away from Market Square and the page should be dedicated to events on Market Square only.

2. Why do other users of the electric on the Market Square i.e. catering truck for Food Festival and other events pay £3.93 per van when they clearly use a lot more appliances?

3. Would it be possible to have extra markets i.e. on a Sunday when markets are cancelled due to weather conditions?

4. Could the market block have a deep clean and revamp (repaint etc) as some new market people have passed comment to older traders?

5. Can more information be relayed for a reduced market in some cases, e.g. when it is posable to trade without covers and just tables set up.

6. Traders should have an incentive to stand on reduced market days i.e. small reduction in rent.

7. On some occasions Buskers have made it impossible to talk to customers in some areas of the market. When traders have complained to LDC they were told that the rules on busking are guidelines with no enforcement.

8. Who has the final say on decisions made on the market day to day.

9. Could Casual Traders pay for pitches up front to help encourage them to turn up or give good notice that they are not going to attend.

### **RECOMMENDED:** That the matters be discussed and answers provided to the Traders following the meeting.

#### 6. FAYRES – REVIEW OF CHARGES

Further to discussions at the last meeting (see Minute 46) and as reported to all members of the group via email on 15 March, the Office Administrator compared current Market Square commercial hire costs to the contracted rate as paid by the Bower, confirming the difference across the Bower weekend to be approximately £160 in the Bower's favour. In addition, the Office Administrator posted a request on the NABMA website to establish some benchmark charges for fayres, but there were no meaningful responses to that request.

After being advised of the charges levied by LDC for the hire of Bird St car park for the Bower, it became clear that a cost per m2 breakdown would reveal LCC charges more for the Square than LDC charges for the car park. The Square is of course more of a 'prime' location and would attract a premium as a result. It is further understood that the LDC charges are under review.

Given the proximity to the next Bower Fayre date, the relatively small difference in current hire charges and costs if the Square was hired under the normal charging regime, plus LDC's current review into its own charges, the recommendation is to keep a watching brief on the situation for now. Once LDC charges are agreed, LCC can then proceed from an informed position for Market square rates based on those charges and any representations the Bower or the Fayre may make to LDC as those discussions continue.

#### Minutes of the Meeting of the Markets Working Group (MWG) held via 'Zoom' on Thursday 15 February 2024 at 6.00pm

**PRESENT:** Councillor C Pinder-Smith (Vice Chair, in the Chair) and Councillors D Baker, M Field, P McDermott and J Smith.

## 40. DECLARATIONS OF INTEREST AND REQUESTS FOR DISPENSATION None.

#### 41. MINUTES OF PREVIOUS MEETING

**RESOLVED:** The Minutes of the MWG meeting held on 23 November 2023 be confirmed as a correct record [Minutes adopted by Council on 11 December 2023].

42. MATTERS ARISING FROM MINUTES None.

#### 43. MARKETS UPDATE

Members considered the agenda report. The Chair asked for further information on the loss of two regular traders, the Markets Officer confirmed both ceased trading for personal reasons, rather than any dissatisfaction with the Market. The Chair then asked if there had been any feedback on the pitch hire fee increases. The Markets Officer confirmed that the Traders had seen the retention of the 25% 'winter' discount as a positive development that offset the rate increases. Cllr Baker enquired as to the Environmental Health interventions on the Square; the Town Clerk confirmed that the affected trader was working with the EHO and the situation was being closely monitored.

The Chair then asked if it would be possible to look at the trend in social media followers/engagements. The Town Clerk confirmed that the snapshots on record could be combined to present such information, and that this would be made available at a future meeting.

Cllr J Smith enquired as to whether the Red Book Bus had returned to the Square. The Markets Officer confirmed it had not, and that enquiries would be made regarding future dates.

#### RESOLVED: That the report be noted

#### 44. ADDITIONAL CHRISTMAS MARKET DAYS - REPORT

Members considered the agenda report detailing the extra Christmas markets held on the Square during the pre-Christmas week. It was agreed that the markets had been a success, particularly as Traders had reported good footfall and wished the provision to be repeated. It was further agreed that the Markets are a positive development for the City, but care should be taken to not adversely impact local shops.

#### **RECOMMENDATION TO COUNCIL:**

Following the popularity of the additional Christmas Markets and feedback from Traders, Council to utilise its powers under the Food Act Part III to formally establish additional Christmas Markets to take place on Wednesday and Thursday in the pre-Christmas week of any given year (for example 2024; Wednesday 18 December and Thursday 19 December, 2025 Wednesday 17 December and Thursday 18 December etc).

#### 45. TRADER REPRESENTATIONS

Members were advised that no representations had been received. *RESOLVED: That the report be noted* 

#### 46. FAYRES – REVIEW OF HIRE CHARGES

The Working Group considered the Town Clerk's agenda report which gave background on the pricing structure for the Shrovetide and Bower Fayres (both provided by Pat Collins Fairs), and the Chamber of Trade Christmas Fayre.

In regard to the Pat Collins Fayres, there was considerable discussion as to the possibilities of increasing charges, the amounts of any such increases, and the potential positive and negative outcomes thereof. It was agreed that any such decision required additional research and comparable evidence to ensure the council was neither pricing unreasonably nor providing an unacceptable subsidy at the expense of the public purse. It was agreed that electricity (as used) should be charged for both Fayres.

In regard to the Chamber of Trade Fayre, it was agreed that 'free use' should continue as per the arrangement that has been in place for many years.

#### RESOLVED:

In regard to the Pat Collins Fayres – LCC officers to prepare comparable hire charge information to be presented to the MWG for consideration at its next meeting. Electricity (as used) to be charged for the Shrovetide Fayre (already in place for Bower Fayre). The matter to otherwise be left in abeyance.

#### **RECOMMENDATION TO COUNCIL:**

That 'free use' arrangements for the Market Square be continued for the Chamber of Trade Christmas Fayre.

#### 47. NATIONAL ASSOCIATION OF BRITISH MARKET AUTHORITIES

Members were given a verbal update on the NABMA conference attended by the Chair, Markets Officer, and Office Administrator. It was noted that the conference did not appear to cater for Markets such as Lichfield as much as would be desired, and that event feedback had been submitted to that effect.

RESOLVED: That the report be noted.

#### 48. MARKET SQUARE BOOKING RESTRICTIONS – VAPES

Following Cllr Blackman's request that this item be added to the agenda due to the 'Project Vaparound' booking on the Square on 31 January, members discussed whether restrictions should be put in place for such bookings in the future.

It was agreed that there needed to be some form of restriction that guarded against what members saw to be thinly commercialised bookings that advertised themselves as having a health benefit, or providing a healthier alternative, when the clear aim was to market their own product. It was also agreed that a blanket ban on products such as vapes would be impractical.

The Working Group was clear in its desire to steer away from such bookings and sought a policy that would assist in eliminating them in the future. A general statement was agreed, with the Town Clerk to discuss appropriateness/wording with LDC's Licensing team.

#### **RECOMMENDATION TO COUNCIL:**

That any Market Square booking purporting to be promoting/selling a product claiming a significant health benefit or as a healthier alternative must have the support of the NHS.

### Markets Working Group 2 May 2024: APPENDIX 1

Five traders joined the Tuesday market:

- Sumac Native native crafts, now left the market but may return
- Jemima Joans craft jewellery
- All kinds of everything pet products & toys
- Olivesz2 olives & nuts etc. This trader may come back to the market if there is space
- Exclusive by Design furniture upholstery
- Simply the best bags natural jute bags
- Audreys Funding Fashions- Children Clothes

The Friday Market has also welcomed a new trader - 'Silver Elegance' selling jewellery.

'The Potting Shed' has now become permanent on the Friday market and Ryan James Butcher has become permanent on Tuesdays and Fridays and is currently working towards becoming permanent on the Saturday market, too.

In April to date, we have had 3 restricted markets 5 April, 6 April and 9 April.

The Market Square has now been deep cleaned with excellent results; pitch location marks are to be reinstalled shortly.



All food stalls are being monitored for standards of food hygiene with the Environmental Health Officer kept informed of any new food trader coming on to the market. All Licences have been signed and PLI checks have been completed to ensure these are current and up to date.

#### Tuesday Market Update

The Tuesday market is now full we have 7 causal traders with one of these 'Simply the Best Bags is now becoming a permanent trader.

#### Friday Market Update

The Friday market is now full, 'Silver Elegance' who sell jewellery are now permanent, so there are no causal traders on Friday.

#### Saturday Market Update

Saturday market remains full. Ryan James Butchers are taking the two recently vacated spaces and will go permanent shortly.

We are continuing to update our contact list of Traders that can cover at short notice. This helps us to keep the market full and eliminate large spaces that can convey a feeling of decline, even when the absence is due to pre-planned holiday or illness.

A full and varied market can only enhance footfall into the city, together with having a positive is also having a positive effect on the reputation of the market and supporting other local business, too.

#### Vegan Market

The Vegan Market runs on the third Sunday of the month. A total of 22 stalls attended the most recent Market, and it is clear that it is getting more popular over time. 2024 dates are confirmed, with promotional posters awaited from the organiser.


#### **Producers' Market**

The Producers' Market is organised by CJ Events and operates on the first Sunday of the month. This market is well supported by traders and is very popular with significant repeat visitors. The Producers' market on March 3rd was attended by 22 stallholders on what was a very cold day. Unfortunately, the April Market was cancelled by the organisers due to the forecast high winds.

#### SOCIAL MEDIA ANALYSIS

As advised in the email to MWG members circulated on 15 March, Clive Read – one of LCC's current Premises Attendants and a former Markets Officer who is both interested in and familiar with social media and its intricacies - volunteered to assist with promotion of both the Markets Facebook page and the new Guildhall Facebook page.

This has been progressing on a trial basis for the past few weeks based on a 4 hours/week allocation which includes photographing markets/Guildhall events, specific features on various traders, sharing posts from other groups/traders etc, all with the aim of increasing engagement. The statistics below show a marked increase in reach, content interactions and link clicks.



The screen capture overleaf highlights the most popular posts of the past 60 days (to 22 April), sorted by levels of engagement that those posts generated, rather than by the number of views.

A wide variety of post 'types' are represented, from spotlights on long standing traders, to the need to cancel/reduce the markets due to bad weather. The post centring on historic photographs of the Square was also very popular – it's 'reach' being higher than any other post in the period - confirming that posts that do not just focus on current markets and traders are well received and can contribute to growing the page.
