### 37 PARKING RESTRICTIONS – BRITANNIA ENTERPRISE PARK

Consideration was given to the request from Staffordshire Highways for views on a permanent Traffic Regulation Order (TRO) to extend the existing parking restriction along D3547 Europa Way, D3547 Britannia Way, Prospect Drive & Titan Way.

**RESOLVED:** *That the Deputy Town Clerk writes to County Highways supporting the proposed parking restrictions, but requesting that the proposed unrestricted parking areas (marked in yellow on the map) be restricted to 30 minute parking in order that vehicles cannot park there all day and to help visitors to units particularly the Royal Mail depot.*

**38 PARKING RESTRICTIONS – TRENT VALLEY ROAD**

Consideration was given to the request from Staffordshire Highways to review the proposal regarding the implementation of a traffic order to provide no waiting and no loading at any time along the A5127 Trent Valley Road, Lichfield between the junctions of Burton Old Road West and Wissage Road.

***RESOLVED: That the Deputy Town Clerk writes to County Highways supporting the introduction of double yellow lines on Trent Valley Road but pointing out that the residents may need loading and unloading outside their houses and to consider allowing overnight parking on the road between 6pm and say 7am. The committee were strongly of the view that we should consider the residents needs on the north side of the road as the yellow lines are to address what is very much a working day problem***
